MIDDLE PENINSULA PLANNING DISTRICT COMMISSION May 27, 2015 Saluda, Virginia

The monthly meeting of the Middle Peninsula Planning District Commission was held in the Regional Board Room at the Middle Peninsula Planning District Commission office in Saluda, Virginia on Wednesday, May 27, 2015, at 7:00 p.m. MPPDC Vice Chairman Otto Williams (King William County) called the meeting to order and welcomed everyone in attendance.

Commissioners in attendance were: (Essex County) A. Reese Peck; (Gloucester County) Ashley Chriscoe, Dr. Maurice "Mo" Lynch, and Sanford "Sandy" Wanner; (King and Queen County) Thomas "Tom" Swartzwelder; (King William County) Eugene Rivara; (Mathews County) O. J. Cole, Jr., Thornton "Tim" Hill, and Charles Ingram; (Middlesex County) Trudy Feigum and Wayne Jessie, Sr.; (Town of Urbanna) Steve Hollberg; and (Town of West Point) Paul Kelley.

Vice Chairman Williams extended a special welcome to newly appointed Commissioners Paul Kelley, Town Council of West Point, and Sanford Wanner, Gloucester Interim County Administrator.

Guests in attendance were Matt Walker, Middlesex County Administrator, and citizen from the region. Middle Peninsula Planning District Commission staff in attendance were Executive Director Lewis Lawrence, Finance Director Beth Johnson, Secretary Rose Lewis, and Planner Harrison Bresee, III.

Approval of April Minutes

Vice Chairman Williams asked whether there were any corrections or changes to the April Minutes. There were no corrections or changes to the April Minutes. Vice Chairman Williams requested a motion to approve the April Minutes as distributed. Ashley Chriscoe moved that the April Minutes be approved as distributed. Tim Hill seconded the motion; motion carried.

Approval of April Financial Reports

Vice Chairman Williams asked whether there were any questions regarding the April financial reports before being approved subject to audit. There were no questions. Vice Chairman Williams requested a motion to approve the April financial reports subject to audit. Charles Ingram moved to approve the April financial reports subject to audit. Ashley Chriscoe seconded the motion; motion carried.

Executive Director's Report on Staff Activities for the Month of May

Vice Chairman Williams requested Lewis Lawrence, Middle Peninsula Planning District Commission Executive Director, to review the Executive Director's Report on Staff Activities for the month of May. The Executive Director's Report on staff

activities is developed at a monthly staff meeting, organized by PDC Service Centers, and the activities are used to report grant funding activities.

Mr. Lawrence reviewed the Executive Director's Report for the month of May as follows:

<u>Project 32010 Staff Support to Middle Peninsula Chesapeake Bay Public</u> <u>Access Authority (MPCBPAA)</u>

• Received word that the Commissioner of Revenue in Gloucester has acknowledged the fact that the Middle Peninsula Chesapeake Bay Public Access Authority is a political subdivision and thus tax exempt.

Project 32132 Virginia Coastal Zone Management Program

• Coordinated for the "Closing the Deal" Federal Flood Insurance real-estate workshop to be held at VIMS on May 19th. Over fifty real-estate, banking, and insurance representatives from across the Middle Peninsula registered to attend.

Mr. Tim Hill (Mathews County Realtor and MPPDC Citizen Representative) said the meeting was very informative and well received by all who attended.

Project 32134 Drainage and Roadside Ditching Authority

• Convened a public meeting in Mathews County to present the Drainage and Roadside Ditching study results and next steps for the project.

MPPDC Executive Director Lewis Lawrence said Mr. O J Cole, Jr. (Mathews County Board of Supervisor and MPPDC Treasurer) was outstanding in managing the meeting.

<u>Project 302101 Transportation Demand Management (TDM) 6 Year Plan</u> <u>Update</u>

• Designed survey to request public input into transportation services needed in the region. Posted link to survey on MPPDC (<u>www.mppdc.com</u>) and Middle Peninsula Rideshare (<u>www.midpenrideshare.org</u>) websites.

Project 30105 Middle Peninsula Broadband Study

• Convened a meeting of the MPBA Board to discuss the Virginia Telecommunication Planning Grant Initiative from DHCD. The Board decided to submit a Letter of Interest by the May 22, 2015 deadline. Due to the resignation of Brenda Garton, new officers were elected. Melinda Conner, Mathews County Administrator was elected Chair and Matt Walker, Middlesex County Administrator was elected Vice-Chair.

Project 30018 Local & Regional Technical Assistance

• Drafted and submitted the Middle Peninsula's comments to DEQ on the State Water Resource Plan.

Mrs. Trudy Feigum, Middlesex County/MPPDC Citizen Representative, requested a copy of the comments that were submitted to DEQ and a copy to be sent to the Local Government Administrators.

Public Comment

Vice Chairman Williams opened the meeting for public comments. There were no public comments.

Vice Chairman Williams closed the public comments period.

<u>Update of the Emergency Planning Program and Scope of Work–Harrison</u> <u>Bresee, III</u>

Mr. Harrison Bresee, III, MPPDC Regional Planner, distributed a list of acronyms that is listed in the Emergency Operations Plan. Mr. Bresee said his role as the Regional Emergency Planner is to support the Middle Peninsula Emergency Coordinators in each locality by assisting and coordinating homeland security and disaster response preparedness, Rt. 17 evacuation planning, and resource data collection. In 2014, the All Hazards Mitigation Committee met on a regular basis and developed a list of needs for the region. A grant was submitted to the U S Homeland Security Grant Program and was approved. This grant, funded for 2014-2015 with no local match, is administered through the Virginia Department of Emergency Management.

Local Emergency Managers identified needs that include (1) develop a Rt. 17 Evacuation Plan, (2) local and regional shelters, (3) coordinate public outreach and education, (4) define and map evacuation zones for storm surge, (5) develop a regional Emergency Operations Center (EDC), and (6) coordinate meetings of Emergency Managers, Law Enforcement, Fire Departments, Rescue Squads, etc.. Needs that were identified by local administrators included (1) loss of volunteerism and recruitment, (2) study to show how to take care of local citizens first during an event when a mass influx of evacuees are expected, (3) regional shelters, (4) special needs sheltering, and (5) regional communication.

Mr. Bresee said the needs exist because (1) counties do not have Emergency Planners on staff, (2) Emergency Managers have many roles, (3) Rt. 17 has no written evacuation plan, (4) The Commonwealth requires local governments to develop evacuation plans that are Federal Emergency Management Agency (FEMA) and National Incident Management System (NIMS) compliant, and (5) evacuation through the Middle Peninsula could overwhelm the region's resources.

According to the 2010 Evacuation Behavioral Study, citizens believe that it is the government's responsibility to meet the needs of people in the event of a major storm.

Mr. Bresee said Year 1 deliverables include (1) Rt. 17 Evacuation Plan-the Plan will assist people to move from the path or threat of a disaster to an area of safety, (2) Resource Typing-NIMS Compliance, and (3) Regional Calendar-assist with coordination between VDEM and local training. Next year, Mr. Bresee said he will apply for an additional State Homeland Security Grant (SHSG).

Discussion was held regarding hurricane preparedness, evacuations, VDOT's role in case of evacuation, shelters, and role of the American Red Cross.

<u>Report of the Budget Committee/Approval of FY16 Budget and Overall</u> <u>Program Design (OPD)</u>

MPPDC Executive Director Lewis Lawrence said for the fiscal year 2016, the Commission is financially stable and represents a strong and well established relationship with State and Federal partners. MPPDC staff has obtained funding commitments to fully fund the Commission's work program for the next fiscal year.

Mr. Lawrence said the revenue available to support the Commission's Overall Program Design will increase by approximately 57.5%. The Budget & OPD Committee offers a budget document and a PDC Service Center budget document which identifies the following service centers to be operated in FY16:

- (1) Agency Administration
- (2) Environmental Coastal Community Development
- (3) Transportation
- (4) Local Projects/Staff Support
- (5) Local/Regional Planning
- (6) Direct Constituent Services
- (7) Mandates
- (8) Emergency and Hazard Management
- (9) Economic Development

MPPDC Financial Director Beth Johnson said the Budget and Overall Program Design Committee met and reviewed a draft FY16 budget.

Mrs. Johnson reviewed the draft FY16 budget of Revenues and Expenses. The FY16 draft budget anticipates \$957,281.00 in revenues and \$847,971.32 in expenses. Savings from VRS (decrease in liabilities) will be utilized to provide a 3% base salary increase for all staff – the first since 2007 and an increase of ~\$1,500 to offset increases in the family health insurance.

Discussion held was regarding rideshare commuter services and ownership and management of car pool lots.

Vice Chairman Williams requested a motion to adopt the draft Recommended Overall Program Design and Budget for FY16. Tim Hill moved to adopt the FY16 MPPDC draft Recommended Overall Program Design and Budget. Eugene Rivara seconded the motion; motion carried.

Report of the MPPDC Nominating Committee

MPPDC Treasurer O J Cole, Jr. said the MPPDC Nominating Committee recommended the current officers of the MPPDC be elected for another year. The following slate of officers for FY16 is:

Vice Chairman Williams thanked the Nominating Committee for the FY2016 slate of MPPDC officers.

Virginia Resources Authority Financing Agreement-Septic Repair Program

MPPDC Executive Director Lewis Lawrence, said staff has been working with Virginia Resources Authority (VRA) for funding from the Virginia Water Facilities Revolving Fund. Sands Anderson looked at the financing Agreement and questioned Section 9.8 Davis-Bacon Act. After discussing the questioned section, an amended Agreement was prepared and agreed upon by VRA, Sands Anderson counsel, MPPDC Executive Director Lewis Lawrence, and MPPDC Finance Director Beth Johnson.

MPPDC Finance Director Beth Johnson said the MPPDC has been repairing septic systems for 19 years. One hundred twelve (112) systems have been repaired or replaced. As of today, there is only \$4,000 left in septic repair funding. The funding agreement with VRA consists of an interest-free loan in the amount of \$200,000 with the payments on the loan to begin two and one-half years after loan closing for a term of 10 years.

Vice Chairman Williams asked Mrs. Johnson is there is a waiting list for septic repair. Mrs. Johnson said that there are two applications and one has been approved and the other is pending estimates, and there are several applications in varying states of completion. Forty-nine loans have been repaid and fifty-one clients are actively repaying their loans

Vice Chairman Williams requested a motion to adopt the Resolution of the MPPDC to accept the loan from the Virginia Water Facilities Revolving Fund and Providing for the Form, Details, and Payment Thereof. Tom Swartzwelder moved to adopt the Resolution. Ashley Chriscoe seconded the motion; motion carried.

DEQ is developing the regulations necessary to implement HB 1364 and SB 1413 regarding local ordinances for monitoring the land application of solid and semi-solid industrial waste and associated land application fees. DEQ is also seeking interested persons to serve on the Regulatory Advisory Panel (RAP) regarding the amendments.

King and Queen County Administrator Tom Swartzwelder said Mrs. Jackie Hart, King and Queen County citizen, would be an asset to the Middle Peninsula to serve on the Regulatory Advisory Panel (RAP). MPPDC staff could offer to serve on RAP if no other local names are suggested.

(2) Dr. Maurice Lynch, Gloucester County Citizen Representative, said Hampton Roads Sanitation District (HRSD) approved contract for wastewater reuse for Nestle Purina Pet Care (kitty litter plant) in King William County.

- (3) Mr. Lawrence said the June dinner meeting will be held at Captain Sinclair's in Gloucester County. The MPPDC Board business meeting will be held, but there will be no speaker for the evening. The evening will be a social gathering.
- (4) Mr. Lawrence announced the meeting of the Town Mayors and County Board of Supervisors Chairs with Delegate Hodges which will be held Thursday, May 28th, at 6:00 p.m.

MPPDC General Fact Sheet

WHAT IS MPPDC?

The Middle Peninsula Planning District Commission (MPPDC) was established pursuant to the Virginia Area Development Act (Title 15.1, Chapter 34, Sections 15.1-1400, et seq., Code of Virginia (1950) as amended) and by joint resolutions of the governing bodies of its constituent member jurisdictions.

The "MPPDC" describes the geographic section of Virginia which encompasses the Counties of Essex, Gloucester, King and Queen, King William, Mathews and Middlesex and the Towns of Tappahannock, Urbanna and West Point.

BACKGROUND

The Agreement to organize a Planning District Commission was made on January 31, 1972, by and between the government subdivisions as authorized by the Virginia Area Development Act.

WHAT DOES MPPDC DO?

The purpose of the Commission is to promote the orderly and efficient development of the physical, social, and economic elements of the Planning District by planning and encouraging and assisting governmental subdivisions to plan for the future.

HOW ARE DECISIONS MADE AT MPPDC?

Decision-making occurs through the Middle Peninsula Planning District Commission, a governing body comprised of elected officials, citizens, and chief administrative officers representing the six counties and three towns in the region.

MPPDC: Membership, Appointments, Committee Assignments, and Networks

Coastal Policy Team (CPT) - The CPT, whose members and alternates represent the Virginia Coastal Zone Management Program's key partners and eight planning district commissions, provides a forum for discussion and resolution of cross-cutting coastal resource management issues. Members serve on the team at the discretion of their agency or planning district commission director. The CPT recommends funding levels to the DEQ Director for coastal zone management projects. (MPPDC Staff 13 years +)

Congressman Robert Wittman's Fisheries Advisory Committee and Environmental Advisory Committee (MPPDC Staff 6 years +)

Virginia Sea Grant Program External Advisory Committee (EAC): The EAC provides stakeholder input on the strategic planning process, the research proposal review process, and on Commonwealth-wide trends and needs. The EAC is a diverse group of end-users including representatives from state agencies, the education community, coastal planning and management, the private sector, and NGOs. (MPPDC Staff 7 years+)

General Assembly Directed Study Panel: Aquaculture production activities; authority of local governments (MPPDC Staff- current)

The Association for Commuter Transportation (ACT) (Telework Council Secretary): ACT is the premier association for professionals and organizations whose focus is the delivery of commuting options and solutions for an efficient transportation system. The Telework Council is composed of employer representatives, regional transportation, air quality and planning officials, as well as state and local government officials concerned with promoting telework and providing telework information and technical assistance to employers (MPPDC Staff 8 years+)

Project 30502 Water Supply Planning

9 VAC 25-780 establishes a planning process and criteria that all local governments will use in the development of local or regional water plans. The plan will be reviewed by the Department of Environmental Quality and a determination will be made by the State Water Control Board on whether the plan complies with this regulation. Within five years of a compliance determination by the board, the plan will be reviewed to assess adequacy and any significant changes will require the submission of an amended plan and review by the board. All local programs will be reviewed, revised, and resubmitted to the Department of Environmental Quality every 10 years after the last approval. The jurisdictions of Essex, King and Queen, King William, Mathews, Middlesex, Tappahannock, Urbanna and West Point opted to prepare a regional plan with assistance from Middle Peninsula Planning District Commission staff and EEE Consulting, an environmental Quality for compliance review by the November 2, 2011 deadline for Regional Plan submission.

Project 31201 Middle Peninsula All-Hazards Mitigation Plan Update

As a mandated requirement of the Disaster Mitigation Act of 2000, the 2016 All Hazards Mitigation Plan Update is designed to update the 2011 Middle Peninsula All Hazards Mitigation Plan (AHMP). The plan will address several natural hazards, including hurricanes, winter storms, tornadoes, coastal flooding, coastal/shoreline erosion, sea level rise, winter storms, wildfire, riverine flooding, wind, dam failures, drought, lightning, earthquakes, shrink-swell soils, extreme cold, extreme heat, landslides, land subsidence/karst, tsunami, and volcanoes.

32012 PAA Captain Sinclair Improvements

The Captain Sinclair's Recreational Area, with approximately 1 mile of waterfront on the Severn River in Gloucester County, VA, is a recent gift from a private landowner to the Middle Peninsula Chesapeake Bay Public Access Authority (MPCBPAA). The MPCBPAA is partnering with the MPPDC to develop an overall use plan for the property that is compatible with the existing natural coastal landscape. The project is centered around protecting and enhancing the local coastal landscape and minimizing wetland impacts associated with constructing a new public pier to improve the current "walk in and over the wetlands" as part of the existing

public access to public waters on the site. A Native Coastal Landscape Design (NCLD) will radiate away from the public access pier. The design will include the purchase and installation of native plants to enhance the coastal landscape around the project site and an educational exhibit on native plants in the main house.

- Received notice from Virginia Department of Forestry of grant award of \$1,350 to MPPDC for installation of a Virginia Coastal Maritime Forest Edge Demonstration Project at Captain Sinclair Landing Recreation Area. The Forest Edge Project will be incorporated into the Native Plant Landscape design.

32013 PAA Maritime Forest Edge Demonstration Garden

The Captain Sinclair's Recreational Area, 100 acres with approximately 1 mile of waterfront on the Severn River in Gloucester County, VA, was a gift to the Middle Peninsula Chesapeake Bay Public Access Authority. The MPCBPAA is partnering with the Middle Peninsula Planning District Commission (MPPDC) to develop an overall use plan for the property compatible with the existing natural coastal landscape. An area of approximately 14,000 square feet to the northwest of the main house has been delineated by the Army Corps of Engineers as nontidal wetlands. This area is adjacent to the area utilized for parking. This project funded by the Virginia Department of Forestry will provide protection for that sensitive area by converting the mowed lawn/ parking area into a demonstration Maritime Forest Edge garden. Approximately 400 seedlings will be planted in the area to provide a small Maritime Forest Edge demonstration garden for viewing by visitors to the site.

Project 32132 Virginia Coastal Zone Management Program

Project 32133 NFWF Living Shoreline

MPPDC received a grant from the National Fish and Wildlife Foundation to facilitate citizen-based resource stewardship to enhance coastal resilience and reduce vulnerability to growing risks from coastal storms, sea level rise, flooding and other threats to shorelines by encouraging Middle Peninsula waterfront homeowners, through access to low interest loans and/or grants and through education about living shorelines, to make informed decisions to install living shorelines to protect waterfront properties. The main emphasis of the project will be to design and implement a Living Shoreline Incentive Program (LSIP) to provide loans and/or grants to homeowners to install living shorelines on suitable waterfront properties. The project also includes the design of a Shoreline Management Plan (SMP) for the entire Captain Sinclair's Recreational Area shoreline and the design and installation of one lower Chesapeake Bay public waterfront demonstration project to provide consumers easily accessible publically owned living shoreline examples to inform their decision making. The investment of effort and resources in producing a Shoreline Management Plan will yield substantial benefits in facilitating decision-making on a variety of potential issues and uses of the site. A Living Shorelines Education Program will be developed to educate the public about the benefits of living shorelines. The Captains Sinclair's Recreation area site boasts an 8,000 sq. ft. waterfront home within 200 feet of the demonstration site that will house the Living Shorelines Education Program.

Gills, Program Manager of Department of Environmental Quality Clean Water Financing & Assistance Program, DEQ staff, VIMS staff, and VRA staff to form stakeholder group to begin development of program guidelines per § <u>62.1-229.5</u> for establishing funds for financing living shorelines. Project 32134 Drainage and Roadside Ditching Authority

To build on past efforts, MPPDC staff will explore the enabling mechanism in which a Drainage and Roadside Ditching Authority may be developed. As this Authority would be responsible for prioritizing ditch improvement needs, partnering with and leveraging Virginia Department of Transportation (VDOT) funding, and ultimately working toward improving the functionality of the region's stormwater conveyance system, MPPDC staff will address the policy questions and create a framework for Drainage and Roadside Ditching Authority that can be scalable to the local or regional level depending on the need.

- Researched and discussed the concept of using nitrogen credit by retrofitting public and private ditches to assist with nitrogen, phosphorus, and suspended sediment removal. The concept could make an environmental negative an environmental asset.
- Developed a format for the final report and began to organize report content.
- Researched stormwater authorities for policies, tools and program structures applicable to the development of a ditching authority.

Project 32207 Working Waterfront Plan

MPPDC staff will build on previous efforts to establish a coastal zone-wide Working Waterfronts Plan for Virginia that will serve to guide communities in protecting, restoring and enhancing their water dependent commercial and creational activities. This plan will help communities with existing water-dependent commercial infrastructure, understand the long-term costs associated with the loss of working waterfronts, develop new policy tools to help them manage the increasing growth pressures, and build capacity to develop working waterfronts as thriving components of local economic development.

DRPT is requesting all TDM agencies update their plan every six years to improve the efficiency and effectiveness of transportation demand programs and services; to serve as a management and policy document for the program; to maximize investment of public funds to achieve the greatest possible public benefit; and to provide a basis for inclusion of operating and capital programs in planning and programming documents such as the Six Year Improvements Program, Statewide Transportation Improvement Program, Transportation Improvement Program and the Constrained Long Range Transportation Plan.

- Designed survey on Survey Monkey to elicit ideas from public on needed transportation services. Posted link to survey on MPPDC and Midpenrideshare websites. Sent email notices to current year rideshare database requesting participation in the survey.

Project 30312 Rural Transportation Planning

This program provides rural transportation planning services through the Rural Transportation Planning Work Program which outlines specific tasks and goals to guide the rural planning of transportation services.

Project 30420, 30423 On-Site technical Guidance Assistance and Revolving Loan Program

The On-Site Technical Guidance Program aids the Middle Peninsula localities and residents in the technical understanding and implementation of approaches to address On-Site Disposal Systems and improve water quality by assisting local homeowners with repairing failing septic systems through low-interest loans and/or grants.

- Received phone call from Liz Whitley, Mathews County, regarding assistance available for septic repairs. Discussed current funding and emailed application.
- Consulted with Camille Dean and Dan Siegel, Sands Anderson, and Shawn Crumlish, VRA regarding closing documents and MPPDC Resolution for closing on new funding from the Virginia Clean Water Revolving Loan fund. Closing is tentatively scheduled for July 1, 2015.
- Discussed new loan funding with Bill Nachman, *Gloucester Mathews Gazette-Journal*. The GJ ran an article on the program which has generated considerable interest by the public. Numerous applications have been mailed to Gloucester County, Mathews County, and Middlesex County homeowners.
- Met with Tara Delaney, USDA Rural Development, to discuss pre-application for a Housing Preservation Grant (HPG) to provide grant funding to low income homeowners for septic repairs.
- Requested feedback on FY14 HPG pre-application submission to USDA from CJ Michels.
- Began preparation of an HPG pre-application for \$90,000 to assist low and very low income homeowners in the Middle Peninsula with septic repairs.
- Executed ACH loan payments for septic loans. All MPPDC loan funding programs require that loan recipients authorize loan payments to be made automatically from loan recipients' bank accounts. Loan clients authorize the payments at loan closing (ACH Authorizations). MPPDC staff process these payments on the 15th of each month. This places the onus to not make a payment on the loan client contacting MPPDC staff prior to the loan processing date of the 12^{th.} of the month to request a payment be held. This has significantly reduced defaults and delinquent repayments of MPPDC loans.

Note: All WQIF grant funds have been spent and all VRA grant funds have been committed. MPPDC staff are continuing to search for additional grant funding for this program. The ability to blend loans with grants is crucial in assisting low income homeowners in correcting failing septic systems. *Remaining uncommitted funding – \$4115 loan funds.*

30441 Septic Pump-out and Technical Assistance Project

This program, with funding from EPA Chesapeake Bay Implementation Grant through the Department of Environmental Quality, will provide septic pump-out financial assistance to low income homeowners and technical assistance to the Town of Tappahannock and Essex County to develop land use ordinance provisions that address the water quality requirements of Phase III of the Chesapeake Bay Preservation Area Designation and Management Regulations (9VAC25-830.10-280).

- Discussed with Joan Salvati, DEQ, the coordination of a meeting with local planners and administrators on the Chesapeake Bay Local Ordinance changes. Ms. Salvati is tentatively scheduled to be present at the Local Government Administrators meeting on July 10th.

Funding - EDA, local match from MPPDC General Fund, BDP Loan Program Income

Project 30104 DHCD Planning Grant—VA Sea Grant Universities MP Partnership

This initiative looks to develop new partnerships with Virginia Universities participating within the Virginia Sea grant Network to enhance Virginia Universities' impacts and value- added services to Middle Peninsula private businesses and coastal localities.

Project 301702 Small Business Revolving Loan Fund

MPPDC agreed to service Middle Peninsula Business Development Partnership's (MPBDP) Small Business Loan Portfolio after MPBDP's dissolution November 30, 2011. MPPDC established a revolving loan fund and staff initiate ACH loan payments from clients bank accounts and manages the accounts. Principal repaid will be held until the Commission determines the best use for these funds as allowed by the USDA (RBEG) original lending restrictions. Interest earned will be used to offset administration costs.

• Executed ACH loan payments for MPBDP loans. All MPPDC loan funding programs require that loan recipients authorize loan payments to be made automatically from loan recipients' bank accounts. Loan clients authorize the payments at loan closing (ACH Authorizations). MPPDC staff process these payments on the 15th of each month. This places the onus to not make a payment on the loan client contacting MPPDC staff prior to the loan processing date of the 12^{th.} of the month to request a payment be held. This has significantly reduced defaults and delinquent repayments of MPPDC loans.

Project 30108 Building Collaborative Communities (BCC) Grant

This project, with funding from the Virginia Department of Housing and Community Development, is a collaborative effort with regional and local, public and private stakeholders to create an organizational structure with the capacity and resources to lead regional economic development initiatives in the Middle Peninsula. The project will seek to provide education, training and outreach to local officials on regional economic development partnerships, re-establish the Tidewater Resource Conservation and Development Council, update the River County Economic Development study, as well as draft policies, bylaws and a conceptual work plan for the newly created economic development organization.

- Consulted with Delegate Keith Hodges concerning economic development across the Middle Peninsula and strategies for starting an Economic Development Organization for the Middle Peninsula.
- Researched various approaches and concepts for possible consideration by the Virginia General Assembly to financially compensate the Middle Peninsula for loss of economic opportunities due to state and federal regulations.
- Consulted with Keith Ruse, owner of Deltaville Boat Yard, concerning interest in Governor Terry McAuliffe Talent Solutions Grant Competition for Economic Development intended to assist:
 - A group of businesses operating in the same industry sector that comes together out of a shared commitment to design and execute an innovative and highly effective training program to develop a talent pipeline of skilled workers for entry level jobs that can lead to career positions.
 - A group of businesses from different industry sectors that have a common workforce development need and join together to design and execute training to develop shared skill requirements in new job applicants or incumbent workers.
 - An individual employer who has identified a need to lead a skills development initiative with companies who comprise that employer's supply chain. In this type of grant application, the large employer takes the lead in working with members of its supply chain to identify common critical workplace skills that can be developed through incumbent or pre-employment training.
- Coordinated and convened a Mayors and Chairs meeting on May 28th hosted by Delegate Keith Hodges. Neal Barber, Community Futures, and Liz Povar, Vice President of Business Expansion with Virginia Economic Development Partnership, presented information to attendees on Economic Development Organizations in the Commonwealth. Representatives from Essex, Gloucester, King and Queen, King William, Mathews, Middlesex Counties, and the Towns of Tappahannock, Urbanna and West Point were invited to participate.
- Researched and prepared draft bylaws and work program for the EDO as guidance tools for the Mayors and Chairs meetings.
- Drafted a quarterly status report and request for an extension for the BCC grant and submitted to Michele Jones, Program Manager with Virginia Department of Housing and Community Development.
- Discussed professional and technical assistance on procedural documents and other resources for an EDO that are available through the SET Expansion Program with Martha Walker, Extension Specialist with the Virginia Cooperative Extension. Also provided Ms. Walker a timeline and update of the status and needs of the project.

Project 30106 Middle Peninsula Regional Jail Flash Freeze Feasibility Study

The Middle Peninsula Regional Jail Authority will use funds from the USDA RBEG program to contract with the Middle Peninsula Planning District Commission (MPPDC) to conduct a feasibility study to evaluate whether, and to what degree, the Middle Peninsula Regional Security Center, local economies, and small scale emerging farms across the Middle Peninsula can benefit from a flash freezing produce program. The feasibility study will assist with exploring and addressing both the infrastructure and capital needs for establishing a freezing program as well as the larger community implications of supporting and enhancing economic growth and community vitality.

- Provided Neal Barber, Community Futures, and Scott Tate with a list of committee members for the kick-off meeting of the Flash Freeze Working Group.
- Hosted the kick-off meeting of the Flash Freeze Working Group on May 26 in Saluda. Agenda items included the background and benefits to the Middle Peninsula Regional Security Center, Project Design and Role of the Working Group, and overview of the Deerfield Correctional Facility flash freeze operation, as well as, discussion of produce market within the Middle Peninsula.
- Researched other flash freeze produce facilities that could be used as a reference for the Middle Peninsula Regional Security Center. For instance, in Elkhart County, Indiana a pilot project began focused on processing fruits and vegetables grown in the area by the Elkhart County Jail inmates in the jail's large commercial-grade kitchen.

Project 30019 Urbanna Oyster Festival Project

This is a shoreline restoration project for Urbanna Creek that proposes collaboration with the MPPDC, VDOT, Urbanna Oyster Festival Foundation, Christchurch School and VIMS. The project proposes to reduce the amount of sediment and nutrients released into Urbanna Creek caused by an enormous hole underneath the bridge that is allowing ground and surface water runoff from public right of way and private property to deposit into the Creek. The project includes filling the hole and design of a shoreline restoration method.

Funding –Housing Loan Program Income

Project 300132 Energy Efficiency and Conservation Block Grant (EECBG)

Summary: Governor Timothy Kaine announced on October 6, 2009 that \$9.7 million in Energy Efficiency and Conservation Block Grants (EECBG) would be distributed on a competitive basis to small local governments. Virginia's 21 Planning District Commissions administered the program and assisted localities in the development of proposals which were ranked and awarded by the Department of Mines, Minerals and Energy (DMME). The program emphasizes a community-based approach to help meet energy and climate protection goals. MPPDC was awarded a contract to provide weatherization renovations to 12 homeowners ineligible for LMI weatherization programs in each of the 6 counties. MPPDC subcontracted the promotion and construction portions of this project to Bay Aging but is tasked with administering the overall project. MPPDC is administering the revolving loan program per DMME.

• Executed ACH loan payments for MPBDP loans. All MPPDC loan funding programs require that loan recipients authorize loan payments to be made automatically from loan recipients' bank accounts. Loan clients authorize the payments at loan closing (ACH Authorizations). MPPDC staff process these payments on the 15th of each month. This places the onus to not make a payment on the loan client contacting MPPDC staff prior to the loan processing date of the 12th of the month to request a payment be held. This has significantly reduced defaults and delinquent repayments of MPPDC loans.

Project 31201 Middle Peninsula All-Hazards Mitigation Plan Update (Reported under Mandates)

Project 31202 Regional Emergency Management Planner

Regional Emergency Planner position housed at the Middle Peninsula Planning District Commission (MPPDC) in Saluda. The Middle Peninsula crosses VDEM Region 1&5 boundaries. Position will support local Emergency Coordinators by assisting/coordinating homeland security & disaster response preparedness; Rt. 17 evacuation planning; & resource data collection.

- Participated in the May 20 Hurricane Evacuation Coordination Workgroup meeting in Newport News. Joined the Shelter Location Identification and Shelter Staffing subcommittees which are intended to design a plan to solve issues identified with Shelter Location and Staffing during a Mass Evacuation.
- Developed MOU's for Essex, King and Queen, King William, Mathews, and Middlesex Counties and the Towns of West Point, Tappahannock, and Urbanna, and a Letter of Intent for Gloucester County. The documents outline the terms of agreement between the Middle Peninsula Planning District

Agenda items include: a discussion with invited guest Kay Karstaedt from the American Red Cross who will discuss the Virginia Capital Region's process with sheltering in the Middle Peninsula localities' needs for funding from the State Homeland Security Grant Program, Resource Typing, and grant programs available for Emergency Services in localities.

Project 30017 King & Queen Fishing Pier Funding

Provide King & Queen County with a contract for services to prepare and submit grant applications to fund the construction of a fishing pier on the Mattaponi River.

• Billed King and Queen County for services provided to prepare, submit, and defend application for grant to build fishing pier at old Mattaponi River bridge abutment.

Project 32128 Land and Water Quality Protection

In light of changing Federal and State regulations associated with Bay clean up-nutrient loading, nutrient goals, clean water, OSDS management, storm water management, TMDLs, etc, staff from the Middle Peninsula Planning District Commission (MPPDC) will develop a rural pilot project which aims to identify pressing coastal issue(s) of local concern related to Bay clean up and new federal and state legislation which ultimately will necessitate local action and local policy development. Staff has identified many cumulative and secondary impacts that have not been researched or discussed within a local public policy venue. Year 1-3 will include the identification of key concerns related to coastal land use management/water quality and Onsite Sewage Disposal System (OSDS) and community system deployment. Staff will focus on solution based approaches, such as the establishment of a regional sanitary sewer district to manage the temporal deployment of nutrient replacement technology for installed OSDS systems, assessment of land use classifications and taxation implications associated with new state regulations which make all coastal lands developable regardless of environmental conditions; use of aquaculture and other innovative approaches such as nutrient loading offset strategies and economic development drivers.

Project 32129 Water Reuse

As recent changes to Virginia Water Regulations have tightened water protection and management, there is a strong need to consider maximizing local and regional water resource that may have financial benefits to localities. This project will explore water reuse, how other localities in Virginia and Nation-wide are utilizing this technique and potential economic impacts to Middle Peninsula localities. MPPDC staff will organize a Water Reuse Stakeholder Committee to discuss associated policy needs and opportunities.

Project 32130 Aberdeen TIF

The Aberdeen Creek TIF project will explore Tax Increment Financing as a strategy to generate revenue to finance dredging and other maintenance issues associated with Aberdeen Creek. The project will entail researching TIF policies and programs implemented in Virginia and defining parameters of the program that will achieve the overall objective. The project proposes a partnership with Virginia Sea Grant to determine cost and revenue projections for proposed maintenance and subcontracting with VIMS on project design.

Project 30015 Tappahannock Comp Plan Update/ Project 30016 Essex Comp Plan Update

The Town of Tappahannock has contracted for the Planning District Commission to provide technical planning support for the Town of Tappahannock's Planning Commission as they go through their 2014 Comprehensive Plan Update Process. Every jurisdiction in Virginia is mandated by Virginia Code Section 15.2-2223 to create and adopt a comprehensive plan that outlines a vision for the future of the community with a twenty year planning horizon. Essex County has contracted for the Planning District Commission to provide technical planning support for the Essex County Planning Commission as they go through their 2014 Comprehensive Plan Update Process. Every jurisdiction in Virginia is mandated by Virginia Code Section 15.2-2223 to create and adopt a comprehensive plan that outlines a vision for the future of the community with a twenty year planning horizon. Along with the Comprehensive Plan, Essex County has contracted for the Planning District Commission to lead the Planning Commission in discussions regarding the future preparation of a Capital Improvement Plan (CIP), and prepare a Virginia Enterprise Zone Designation (VEZD) application for the *County. The Virginia Enterprise Zone (VEZ) program is a partnership between state and local government in* which both parties seek to improve economic conditions within designated localities. The program is meant to complement additional local, state, and federal economic development activities to create an improved climate for private sector investment and to focus limited resources on strategically targeted areas. A proposal will be submitted on behalf of the locality by the deadline of June 28th, 2013 using the Department of Housing and Community Development Centralized Application Management System (CAMS).

Project 32208 Working Waterfront-VIMS

This effort will assist VIMS, Marine Advisory Services in the delineation of prevailing economic, zoning and property ownership directly related to Aberdeen Creek. Investigate any existing institutional impediments or legacy constraints to future redevelopment of a seafood related infrastructure on the Creek.

Project 30105 Middle Peninsula Broadband Study

The EDA Broadband Initiative is a project designed to bring together Middle Peninsula counties and towns in a series of workshops with the intent of determining the proper model to follow in developing and running a broadband service in the MPPDC region.

Project 30020 Middlesex Boat Pier

Middlesex County requested MPPDC/PAA staff to perform the necessary work to develop project proposal for Virginia Department of Game and Inland Fishery grant funding. The proposal would seek funding for the planning, design and potential construction of a new public access site on Mill Creek in Deltaville that would include a double boat ramp, a courtesy pier and a parking lot that could accommodate trucks with boat trailers
